



Health and safety responsibilities for employers and businesses

During the current Coronavirus Covid-19 outbreak business owners must take all reasonable steps to ensure that their staff, customers and any other persons e.g. delivery personnel, contractors etc. who come into their premises are not exposed to the virus and that measures are in place to control the spread of it. The enclosed business checklist will help you to ensure that you have put adequate controls in place.

Social distancing requirements must be implemented in every workplace, regardless of size. As a business

owner you have a duty to ensure that everyone who works at or accesses your premises can socially distance to protect themselves and others within your premises and that any controls are enforced by management
