"Thank you for the opportunity to consider the MEA Council Local Development Plan, which reflects the objectives of Putting People First, as outlined on page 31. MEA Council is to be commended for having aligned its Corporate Plan with the thematic structure of the Community Plan and having incorporated within the Local Development Plan aspects of direct relevance including Criteria for Safety and Safeguarding of Human Health/Wellbeing (page 111 & 118) and particularly the commitments to Building Sustainable Communities throughout section 8 (pages 170 -207). This includes sections on housing including adaptable and accessible homes (p181) and commitments on use of land for open space, sports/recreation and leisure (194-207) which accord with Community Planning outcomes on health and wellbeing. The Plan also contributes to addressing the underlying causes of poor health though economic growth, sustainability, transport. With regard to capital development, Section 8.3 (p208) outlines the aim of improving the health and wellbeing of the MEA community and outlines a policy commitment in support of use of land for health and related purposes. It is worth noting this commitment extends to proposals for alternative use of existing facilities for such purposes requiring to demonstrate having become surplus to requirements and not be viable for alternative community use. In addition we note that the Local Development Plan should allocate sufficient land to meet the anticipated needs of the community in terms of health, education and other public services. It is therefore important to protect land for new education, health and cultural facilities. It also states that new facilities must be based in appropriate and assessable locations within settlement areas where there is good connectivity with public transport and active travel infrastructure. In terms of the Technical Supplement 11 Heath, Education, Community and Cultural Facilities it states that the following proposals have been identified by the Northern Health and Social Care Trust as intended capital developments within Mid and East Antrim. However, it should be noted that these are subject to approval of capital allocation by the Department of Health which determines capital allocation regionally. • Replacement of three Adult Centres (this is Carrickfergus, Larne and George Sloan and it is unlikely, given the lack of capital to address all of the Trust capital requirements, that all 3 will be funded in the short to medium term) • Replacement of Slemish House, Children's Centre (this is now a refurbishment solution in the



medium term) • Replacement roof and refurbishment of Pennybridge stores (the Trust is assessing the cost and viability of upgrading this building).
